Objectives and Investment Policy

Objectives

The fund aims to provide income and capital growth by investing in equities of real estate companies worldwide.

Investment Policy

At least 80% of the fund will be invested in equities of real estate companies worldwide. The fund seeks exposure to cities that we believe will exhibit continued economic growth, supported by a number of factors such as strong infrastructure and supportive planning regimes.

The fund is not designed to have a bias to any particular country or size of company.

The fund may also invest in collective investment schemes that invest in equities of real estate companies, warrants and money market instruments, and may hold cash.

Derivatives may be used to seek to achieve investment gains, to reduce risk and to manage the fund more efficiently.

Benchmark

This unit class is not managed with reference to a financial index.

Dealing Frequency

You may redeem your investment upon demand. This fund deals daily.

Distribution Policy

This unit class accumulates income received from the fund's investments, meaning it is kept in the fund and its value is reflected in the price of the unit class.

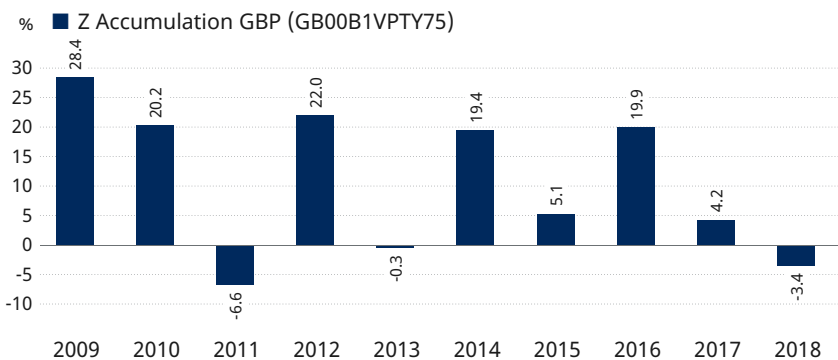
The charges you pay are used to pay the costs of running the fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.
